

1 Product Enhancements

We've made some improvements to ATIPXpress for version 11.1.0. See the sections below for the product enhancements you can look forward to in the latest version of ATIPXpress.

1.1 Application

ID	Feature	Description
19205	OPEXUS Rebranding	We've updated the software to reflect our rebranding as OPEXUS, including all applicable references, updated system fonts, and contact details.
19168	Hosted User and Administrator Manuals	The "Online Manual" link under the Help menu now links to a hosted version of the User and Administrator Manuals by default. This link will always provide the most up-to-date version of the manuals. This link is also configurable, and an offline version of this manual can be provided upon request for organizations utilizing an intranet.
11869	CCPay Online Payment Connector	Added a new CCPay online payment connecter which allows the public to submit application fees, advance request payments, submit payment on invoices, and receive refunds for payments submitted via CCPay. Requesters using CCPay see an on-screen confirmation when a payment is made successfully and receive a payment receipt via email (which is also logged in the Correspondence Log).
11950	Mandatory Responsible Program Office Field	Request Custom Fields can now be configured to require the custom field to be completed before the request can be closed.

ID	Feature	Description
16476	Request Search Verbiage Update	In Request Search, revised the "Search in Request Attachment" option to read "Search in all Received Correspondence." This option now returns all results in Received Correspondence rather than only request attachments.

1.2 Correspondence

ID	Feature	Description
3358	Correspondence Log Email Attachments	In the Correspondence Log, you can now identify any email attachments when viewing the email details. This allows you to reference the attached documents when downloading or printing emails. Additionally, downloading the Correspondence Log includes all emails along with any attachments.

1.3 Document Management

ID	Feature	Description
3361	Find and Replace with Multiple Codes	The Find and Replace option in the Document Management is now enabled to find and replace single redaction codes with multiple redaction codes as required. The previous system only allowed users to select one redaction code when using find and replace.

1.4 Reports

ID	Feature	Description
9627	Scheduled User Action Report	The User Action Report can now be scheduled with predefined date ranges to assist with automated scheduling of reports.
12730	Export Reports to Excel	All report data can now be output in Excel (XLSX) format.

1.5 Administration

ID	Feature	Description
7925	Use Holiday Lookup Table to Adjust Due Date	Added a new option under Request Configuration, "Use Holiday Lookup Table to Adjust Due Date." If this option is selected, the due date advances based on the holiday lookup table, ensuring that due dates do not land on a holiday (but without using the holidays to calculate the initial due date unless that option is specifically selected).
8368	Removed IE- Related XBAP Settings	Removed all IE related XBAP configuration settings from the application.
13186	Multiple Scheduler Support	Multiple schedulers can now run in parallel to reduce processing times, for example with base count calculations.

19899	Change Login IDs	All users in the Admin group can now use the "Change Login" function to change users' login names. This ability was previously reserved for the primary application "Admin,Admin"

1.6 Security

ID	Feature	Description
12844	Audit Log Action Tracking	The system now tracks all system interactions for security purposes. Previously the system logged only completed actions. However, if a user without permissions attempted an action but was denied due to lack of permissions, this was not logged. Now the Audit Log tracks all system interactions including permission checks, and these are reportable via the audit log.
9569	Moneris Validation	ServerCertification validation now occurs for Moneris, preventing any insecure SSL vulnerabilities.
9589	PAL Security Enhancements	Fixed "Access Control DB" vulnerability detected in PAL.
9590	PAL Security Enhancements	Fixed "Non-Serializable Object Stored in Session" vulnerability (ASP.NET Bad Practices) detected in PAL.
9594	PAL Security Enhancements	Fixed "Dynamic Code Evaluation: Unsafe Deserialization" vulnerability detected in PAL.

2 Bug Fixes

We've addressed some issues identified by our customers as well as our OPEXUS team. These bug fixes are outlined in the table below.

ID	Description
7984	Revised the error message that appears when an there are issues processing payments via the online portal. The message now reads "There is an issue with the payment portal, please try again later."
8145	Resolved issue where the Request Information page did not refresh when saving changes after modifying the request description.
8185	Corrected issue when configuring the new action office association to request types if previous request activity exists for the request type the retention details may be cleared in configuration causing an issue saving the new action office association.
8296	An issue was identified when using the Duplicate Request Check option where requests linked during the duplicate check would override the existing linked requests. Now, when linking requests containing existing links, users are prompted with the option to overwrite the existing links or append the links to the current list.
8297	Issue reported where the wrong correspondence editor is presented when accessing the Response Package Approval has been corrected.
8440	Resolved issue where redactions moved to page margins were appearing smaller when using the Print or Save to Disk options.

Bug Fixes

ID	Description
9318	Fixed an error that occurred when attempting to delete a program office that was not associated with any requests. The system incorrectly presented an error message indicating that the office could not be deleted as it was associated with requests.
10520	Resolved an error when creating a new Request for Documents and using the "Other" option for the recipient, however the manual entry field could not be edited.
10524	Corrected an error where a request's multi-track type was cleared after creating an appeal. The multi-track type was correctly captured in reports and raw data but would occasionally fail to appear on the Request Information screen.
10960	Corrected issue encountered when attempting to use the Review button to provide a response package approval. The system presented an error message indicating that no item was selected despite there being a document in the package.
11697	Resolved reported issues where using the Request Description field produced different results between Request Search and the Request Report. We also revised the wild card search guide to provide accurate instructions for using the search feature.
11883	Resolved issue where correspondence emails could not be downloaded, with an error indicating that there was no associated attachment. Emails can now be consistently downloaded regardless of whether an attachment is present.
12819	An Administration issue prevented the system from retaining updates to the Original Document Location, resulting in errors when uploading documents to EDR.

ID	Description
12862	Removed the asterisk in the Request Description field that was present by default when running a Request Report, as wildcards (utilized with the asterisk) do not apply to this search.
13337	Adjusted DM page viewing behavior so expanding the final section in an extended list now scrolls the list view downward, focusing on the section that was just expanded. Previously this would expand the content but maintain a static view, requiring the user to manually scroll down to view the expanded section.
13362	Resolved a customer reported issue where scheduled reports produced different results from a manually run report despite both using identical parameters.
16218	Users with Application Role permissions can now add users the EDR Role. Previously, only users in the Admin group could add users to this role.
17031	Resolved an issue where requests were not deleted from the Recycle Bin per the configured rules because these were not assigned a Request Owner.
18045	Fixed an issue where the system did not generate a new request number when moving the request to a new Action Office, despite selecting the Generate New Request Number option.
18575	Removed Media Redaction Objects under configuration for environments that do not utilize the Media Redaction feature.
