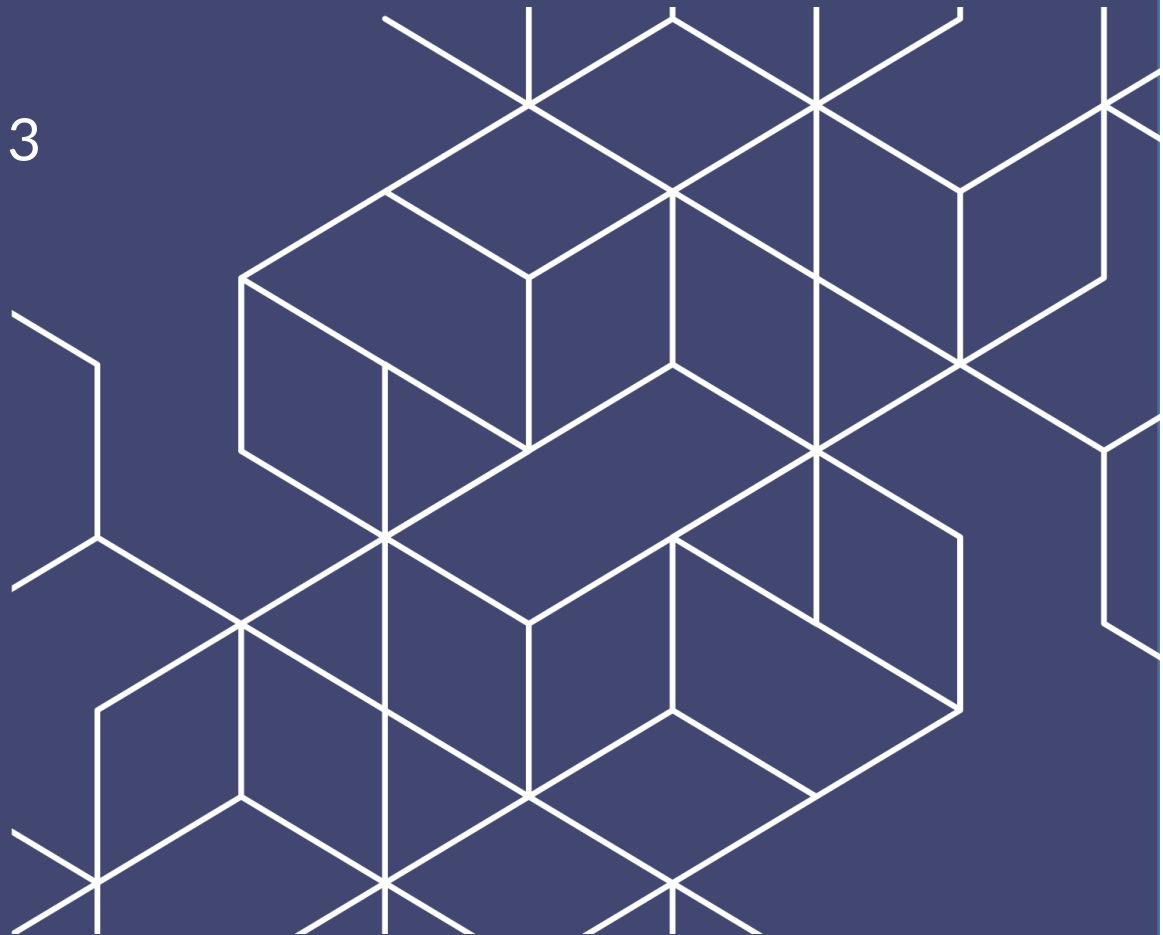

Product Enhancements

We've made some improvements to eCase for version 11.0.2. See the table below for the enhancements you can look forward to in the latest version of the eCase platform:

ID	Feature	Description
22480	XML Format for Scheduled Crystal Reports	Crystal Reports can now be scheduled to export in XML format. When scheduling Crystal Reports, select XML under the Format Type to utilize this new format. Note that XML is only available as a format for Crystal Reports.

Bug Fixes

We've addressed the following issue in eCase 11.0.2:

ID	Description
12269	Fixed a 508-compliance issue in the eCase Portal. When a form submitted via the Portal does not pass validation, the system now focuses on the Validation Summary to ensure the validation issues are read by screen reader software.
16260	"Zero padding" is now enabled by default in the case number formatting for new case types, ensuring case folders under this type can be sorted correctly.
19129	Fixed a bug that caused users to be assigned the incorrect office based on the permissions of the administrator managing that user's account.
19375	Fixed an issue where the Processing Times Report did not return any values despite matching values being present in the system.



ID	Description
21605	Applied minor formatting changes to improve TimeXpress styling.
21744	Fixed an issue where changes made using the bulk assignment feature were not reflected when searching in the application. Now, any changes made to Lookup Search or Lookup Multiple Values fields via bulk action will be reflected in the search results.
21900	Fixed a TimeXpress error that prevented Excludable Days from calculating as expected.
22164	Fixed an issue where some data fields ("secondary source" data) were not saved after users were prompted by the system to save their changes. Changes to these fields can only be saved using the dedicated "Save" button for these "secondary source" fields.
22194	Fixed an issue in the UI Designer where the "Table Properties" tab remained disabled after a Panel element was selected in the designer. Now, selecting the Panel element enables access to the "Table Properties" tab.
22248	Fixed an issue with timesheet reminder notifications that caused the Send Email button to trigger the "Timesheet Approval Pending Notification" email rather than the "Timesheet Reminder Notification" email.
22313	Special characters can now be used in case number searches to capture any legacy cases which may include these special characters in the case number.
22393	Resolved UI Designer issues that occurred when attempting to delete a Panel within a Repeating Table.
22395	Fixed an issue where TimeXpress encountered a "Column Not Found" error when generating custom leave reports.



ID	Description
22542	Revised the Contact Quick Search functionality to include implicit wildcards, ensuring all potential matches are returned in the Contact search results.
22803	Fixed an issue where using the “Add Code(s) to List” option took an overly long time to load and, once open, tasks took too long to move between tables.
22899	Fixed an issue where Rich Text boxes did not accurately trigger system rules, and a related issue where the system was not correctly validating if these fields were blank.
23018	For applications configured for OAuth SMTP, if a web exception occurs when sending an email, information about this exception (“response details”) are now included in the job log.
23166	Fixed a TimeXpress issue where timesheets for the period of December 2022 to January 2023 appeared as blank despite having entries present. These time periods now appear correctly on user timesheets.
23316	Fixed Case Type selection issues that occurred after the Case Types were configured at the Group level.
23412	Fixed a TimeXpress issue where the timesheet status did not accurately update after the timesheet was submitted.
23892	Fixed an issue in the Online Editor which caused collaborative documents to become corrupted, with some instances of data loss.
23893	Fixed issues in the Online Editor which prevented the application from retaining changes made to Word documents.



ID	Description
23894	Fixed an issue which caused PDF files maintained in Document Management to become corrupted.
23895	Fixed an issue where changes made using the online editor were not retained after the documents were checked back in.
23991	Fixed a Portal sync error that occurred due to issues retrieving choice list values.
