80636	An alert message now appears if a tasks and subtask pair is duplicated on a TimeXpress timesheet.
83591, 83593	Various fixes for Section 508 compliance and accessibility.
84037	Fixed an issue where boolean search results with formatted text would display with encrypted text rather than plain text.
84182	Resolved a bug where the application timed out before the session limit when editing a PDF.
88876	Addressed a bug in which the Delegate Approver would not save to the employee profile in TimeXpress, preventing data from appearing on the Project Cost tab.
89506	Corrected a bug impacting the chat function in the online editor.
92462	When No Local Files is enabled in eCASE Admin > General Settings, users will receive a notification email when the file fails to save to eCASE from editing in OnlyOffice, but the email will not contain the attachment download link. There is no way to recover OnlyOffice edits when No Local Files is enabled.
