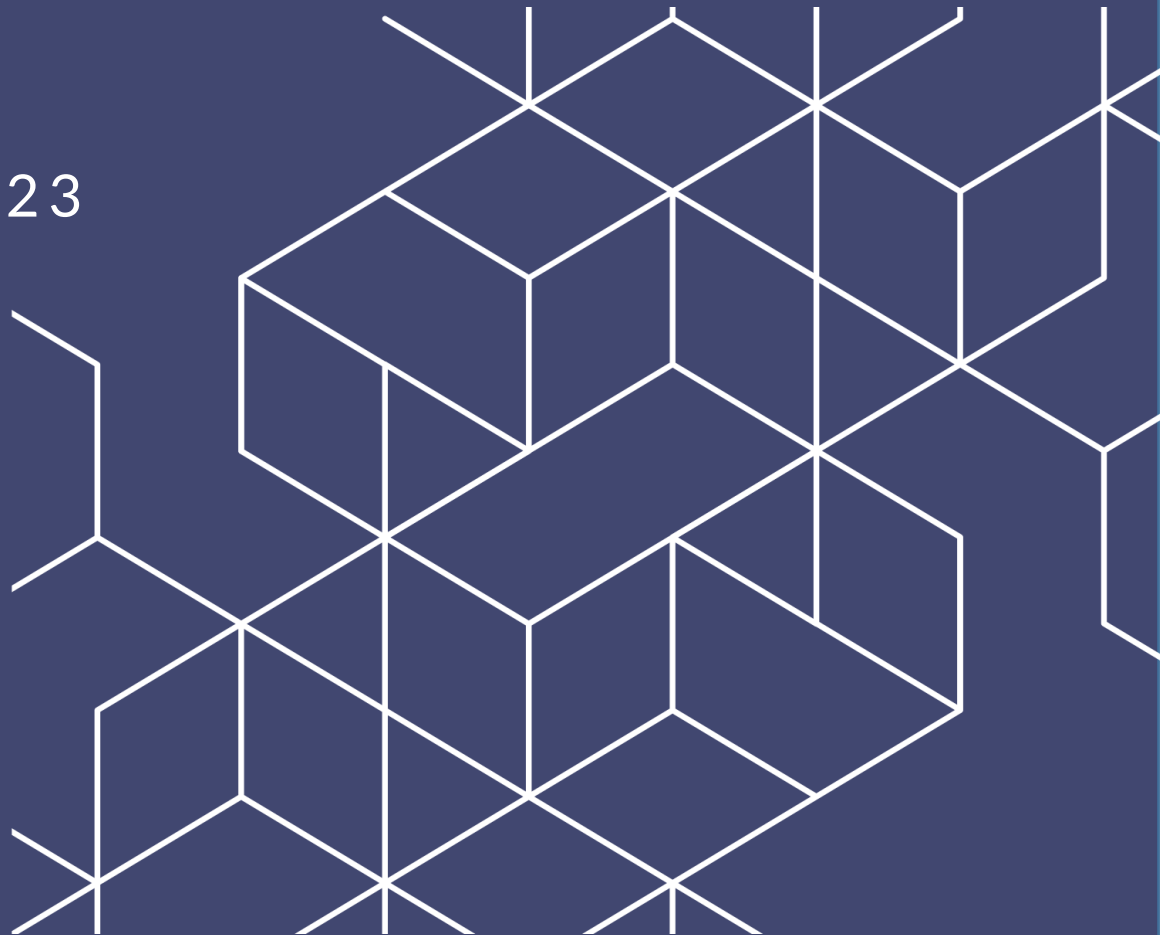

### Product Enhancements

We've made improvements to the FOIAXpress Collaboration Portal for the latest version. See the sections below for the product enhancements you can look forward to using in v11.1.0:

ID	Feature	Description
8168	Support Contact Update	The support@ains.com link has been removed from the "About" application screens.
8169	New Technical Support Link	A Technical Support link has been added to the Help drop down list, which your agency can use to provide instructions for users to receive technical support. The default configuration is for users to reach out to OPEXUS Support; however your agency now has the option to customize instructions for Collaboration Portal users.
8170	Configurable System Notice	Added the System Notice feature to Collaboration Portal Administration, allowing agencies to configure messages or warnings to display on the portal dashboard. These messages can be configured to display on given date ranges, for example informing users of holiday outages.
11350	Configure "From" Email Address	The "From" email address is now configurable for the Collaboration Portal. Use the Mail Server Address option under General Configuration to configure the "From" address for messages received from the collaboration portal (otherwise this defaults to the Admin user's email address).



ID	Feature	Description
11379	Removed Duplicate Disclaimer Configuration	In Collaboration, we removed the duplicate Disclaimer Configuration under Application Templates. The Disclaimer Configuration options are now only found under General Configuration. We also added the option to display the disclaimer at either the top or the bottom of login page, and the disclaimer is also now present even when SSO is enabled.
11382	RFD/Consultation Interface Improvements	Made multiple improvements to the Request for Documents/Consultation User Interface, including: <ul style="list-style-type: none"> <li>• Replaced "Task ID" with "RFD ID"</li> <li>• Subject now defaults to read "Request ID"</li> <li>• Presents the RFD/Consultation ID tracked in FX/AX</li> <li>• More space added to the Message Body field</li> <li>• Removed the "Click to Review Submission" button</li> <li>• Improved instruction location</li> <li>• Track submission dates for submitted attachments</li> </ul>
