## **Bug Fixes**

We've addressed the following bugs in this version of FOIAXpress:

ID	Description
62157	Fixed an issue where PAL requests deleted from FOIAXpress were still appearing to the requester in PAL. The requests will no longer be visible after deletion.
82141	Addressed a bug restricting the deletion of a PAL Configuration Admin User who has associated emails in the Admin Email log.
97091	Resolved an error encountered while attempting to save Request Report criteria with 200 request types. The Request Report performance can now run with larger datasets, i.e., 250+ request types.
99166	Fixed a bug where a selection of Find and Unredact options were unavailable.
99939	Addressed a bug where the number of allowed Collaboration Scan Users were not being updated while the Scanning Role window was open, thus allowing the number of Scan Users permitted in the license to be exceeded.
100532	Corrected a bug where if only the Name value of a Correspondence Template was edited, the changes were discarded and if another field was edited along with the Name, the original version of the template remained unchanged with the original name while a new version was saved with the edits under the new name. The Correspondence Template can now be renamed without any issues.
