

HTTPS Endpoint Requirement

The Collaboration Portal now requires an HTTPS endpoint to be configured for the Collaboration Portal URL. See the <u>Collaboration Portal Deployment Manual</u> for instructions to configure your application to function with a qualified HTTPS endpoint.

Bug Fixes

We've addressed some issues identified by our customers as well as our OPEXUS team. These bug fixes are outlined in the table below.

ID	Description
21496	Updated the Collaboration Portal so that improper sign outs, such as closing a browser window or tab without logging out, are recorded in the Audit Log. Users are now brought to the login screen or returned to their current session when returning to the URL after an improper sign out.
22719	Updated the Collaboration Portal One Time Password process for smoother log ins. If a user enters an incorrect OTP, the user is notified rather than redirected to the username/password fields. If the session expires during OTP login, a new OTP will be sent upon page reload.
26361	Attempting to request a Forgot Password email in Collaboration Portal was resulting in an error when configured with Basic Authentication SMTP. We've corrected this issue and Collaboration Portals configured for Basic Authentication can now receive Forgot Password emails.
27645	Resolved a Collaboration Portal bug in which users could not select the Include Correspondence checkbox if Send via Collaboration was selected, preventing correspondence from being added in collaboration consultation tasks.
